- The intending bidders participating in the bidding shall provide the following documents along with their financial bids:
- Company Profile
- Certificate of incorporation/ registration from the registering body
- NTN and Sales Tax registration certificate (in case of exemption, proof should be annexed with the bid)
- Affidavit declaring that the company/firm has never been blacklisted by any Government Department/ Authority/ Agency/ Company
- The procurement procedure shall be **Single Stage Single Envelope** as per Punjab Procurement Rules 2014. This procurement will be governed by the Punjab Procurement Rules, 2014 which may be downloaded from the website www.ppra.punjab.gov.pk.

- A refundable bid security/CDR of Rs.12000/- to be submitted with the bids in favor of "Infrastructure Development Authority Fund".
- Procuring agency may reject all the bids any time prior to acceptance of any bid as laid down in Section 35 of the Punjab Procurement Regulatory Authority Rules, 2014.
- The interested bidders shall submit the bid in a single package consisting a sealed envelope marked as "Financial Proposal", containing name of the firm/ agency, in the office of Chief Executive Officer Infrastructure Development Authority Punjab, Ground Floor 7-C-1, and Gulberg III Lahore on or before **01.08.2016 by 01.00 p.m.**
- The Financial Bids will be opened on **01.08.2016 at 02.00 pm** by the procurement committee in presence of the authorized representatives of the company/firm.
- If the day of submission / opening of bids is declared as holiday the bids will be opened on the next working day.
- Payment will be made through only cross cheques after deduction of all types of taxes on prescribed rates after receipts.
- Inspection / acceptance of items must be according to the specifications laid down in terms and conditions.
- Bidders are required to submit rate of each item along with the total amount.
- Non-compliance will result in rejection of bids.
- Late tenders will be rejected and returned unopened to bidders.
- There will be no price negotiations with the lowest evaluated responsive bidders. Suppliers are therefore requested to submit their lowest and best prices with their tenders
